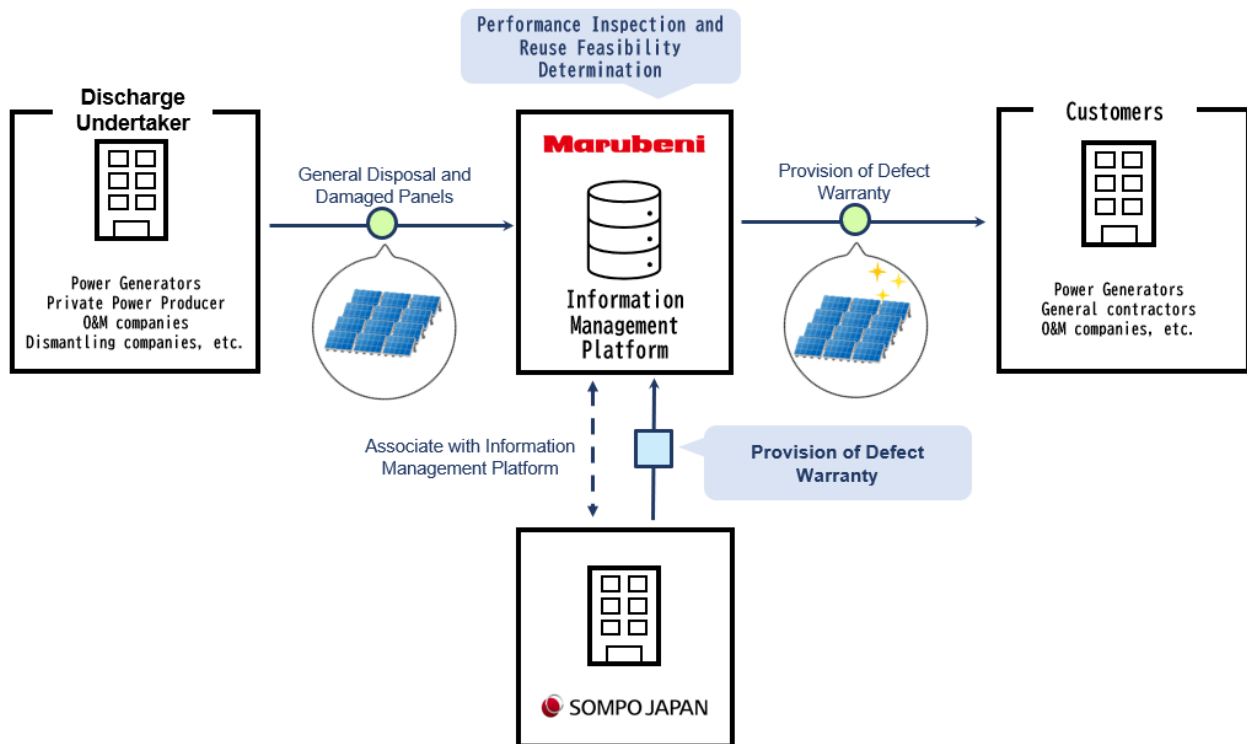

**Memorandum of Understanding  
for Appropriate Reuse and Recycling of Used Solar Panels**

Marubeni Corporation (“Marubeni”), Sompo Japan Insurance Inc. (“Sompo Japan”), and Sompo Risk Management, Inc. (“SOMPO RISK MANAGEMENT”) have signed a Memorandum of Understanding (“MoU”) for the appropriate reuse and recycling of used solar panels.

This MoU establishes a system under which Sompo Japan will provide a defect warranty for used solar panels that Marubeni plans to start selling in FY 2023 via an information management platform (“PF”) that is being entrusted a demonstration project\*1 to the Ministry of the Environment.



Defect Warranty Scheme

Solar power plants in Japan have continued to expand since the introduction of the Feed-in Tariff\*2 in July 2012, with a cumulative total of approximately 64 GW installed as of the end of September 2021. Furthermore, the Sixth Basic Energy Plan\*3 aims for a cumulative installed base of approximately 104-118 GW by 2030. However, since the lifespan of a solar panel is approximately 25 to 30 years, the expected mass disposal of used solar panels in the mid-2030s is becoming recognized as a social issue.

Quality assurance is a significant issue when it comes to the reuse trade of used solar panels. This marks the first time in Japan\*4 that a defect warranty for used solar panels has been provided through a platform. In addition, the used solar panels acquired by Sampo Japan, for which Sampo Japan will pay insurance claims, will be properly reused and recycled in collaboration with PF through SOMPO RISK MANAGEMENT. Reuse and recycling through the scheme above are expected to lead to the recycling of raw materials and a reduction in the amount of industrial waste sent to landfills.

As part of its efforts to promote sustainability management, Marubeni will continue to actively engage in renewable energy power generation projects, including solar power generation projects, and will take the initiative in addressing social issues related to the disposal of solar panels from a 3R (Reduce, Reuse, Recycle) perspective, aiming to contribute to a circular economy.

Sampo Japan and SOMPO RISK MANAGEMENT are committed to making social contributions toward the realization of “SOMPO’s Purpose,” which focuses on “building a society where all people can enjoy their own lives in good health and abundance and enjoy the feeling of living in a kind of ‘theme park’ of safety, security and health.”

Starting with this MoU, Marubeni, Sampo Japan, and SOMPO RISK MANAGEMENT will jointly address social issues and contribute to the formation of a circular economy.
